FYI:

We are sure that the current rise in fuel costs, and projections for diesel to exceed \$5.00 per gallon later in the year, is of great concern to everyone. It certainly is to us, as fuel is our biggest expense. In order for us to continue to provide quality dive trips to the Flower Gardens, it may become necessary to implement a "fuel surcharge" to offset a portion of this additional expense.

Unlike other service providers and industries, we have chosen not to increase our base trip price, but instead, implement a fuel surcharge based on current fuel prices. This way we can reduce or eliminate the additional cost to our customers should fuel costs decrease.

A fuel cost base surcharge will be added as follows:

No additional charges: Fuel cost remains below \$3.50 per gallon
\$30.00 per person charge: Fuel cost rise to between \$3.51 and \$4.50 per gallon
\$60.00 per person charge: Fuel cost rise to between \$4.51 and \$5.50 per gallon

We have always strived to provide an affordable, safe and enjoyable dive experience to the Flower Gardens, and will continue to do so. With your help and understanding we can survive these unprecedented fuel price increases. We sincerely appreciate your continued patronage and hope to see you and your customers in the Gulf very soon.
